"Motives" Invoked by CBBB former CEO to Terminate License

"AS",

I wanted to meet with you yesterday, and give you the option to repair this artificially-created disaster in a most honorable way, and with a least negative impact for BBB, or anyone else. I've asked you to consider my proposition, and to reply with your position ASAP. In lack of a reply I will consider that your choice is to go forth and discover exactly what happened starting September 27...30th..., to discover exactly what happened, which individuals/companies...and most importantly, to insure that those individuals/companies who have intentionally caused this/participated in this, answer for it.

In lack of a reply, I will consider this to be your option, and I will ask those individuals/companies concerned to understand that it is your choice to proceed as outlined above.

NOTE: Prior to the 1st General Assembly meeting, "AS" is offered a compromise-deal where he would occupy a position of National Membership, with the option of becoming a member of the BOD prior to the next launch. All procedures to uncover and hold accountable those responsible for the October 7-11 scandal would stop. In exchange he is asked to learn from this, and make a real effort to mediate a conciliation between the identified responsible parties and myself.

"AS" was on the verge of accepting this deal, asking that he be allowed to consult with ***** and ***** prior to accepting this deal. However, following this, ***** , "AS" and ***** contacted the CBBB former CEO/his assistant, obtaining their support such that the night before the first General Assembly, a letter was received from the CBBB former CEO, which was read by ***** during the GA meeting, urging the BBB RO members to move on and forget about uncovering the events of October 7-11, in effect preserving the notion resulting from the accusations that I was responsible for the missed launch, and disregarding any rights of those who composed the BOD and GA of BBB Romania – rights earned through membership – rights entitling them to evaluate what were the reasons/actions/events, that caused the cancelation of an International Gala Event – event which also represented their efforts, money, trust, time – the rights that any other BOD member would have in Canada, and the United States?

Despite the unauthorized and unethical interference, the General Assembly voted to have the events of October 7-11 uncovered. Irresponsible interference eliminated any possibility for a constructive conciliation with those responsible.
